From Hwy 24: Take Sam Ridley Parkway east past the business district, and after going through the light at Motlow College (lt) & Mason Tucker (rt), move into the right lane and exit to Hwy 41, circling and continuing to the right toward La Vergne. Take a right at the second light onto Fergus Rd. (Exxon Tiger Market on the corner).

Go approximately 0.8 miles and turn right onto Jones Mill Rd. Go approx. 1.8 miles and turn left onto Old Jones Mill Rd. The clubhouse and parking lot will be on your left after the road turns to gravel.

If you come in from the North on Hwy 41, you will turn left on Fergus Rd and continue as above.
